In Texas, 58,000 people filed pro-se — or lawyerless — cases in family courts in 2012.

The Texas Family Law Foundation said it was disappointed with the court’s decision, commenting that it’s dangerous to take Texans down the path of do-it-yourself litigation. The Family Law Section of the State Bar of Texas warned of the potential for confusion and chaos.
